By signing below the Debtor/s/Executor/s agree to the following:

1. PTF has the right, notwithstanding the fact that the funeral has been advertised, to withhold its services and to postpone or cancel the funeral if payment is not made at least 48 hours prior to the scheduled time of the funeral. In the event of cancellation by either party, the Debtor remains liable for disbursements PTF incur.
2. Debtor will provide full payment as per this Agreement. Debtor has read these T&C and understands that failure to meet these terms will result in immediate legal action to recover the full debt plus recovery expenses.
